 K. Ellis-Scharfenberg reviewed the contents of 5.1 Year-to-Date Financial Report as follows:
 - The Ministry of Health has authorized a 1% increase in base funding for 2024.
 - Salary and benefits (including OMERS) are the largest draw on the cost-shared budget and currently overspent due to the costs incurred in the first quarter for COVID-19 case and contact salaries that the Ministry of Health is not expected to reimburse.
 - Non-salary and staff development is currently under budget, with the expectation that funds will be utilized by year end.
 - Ontario Seniors' Dental Care Program is currently being monitored for a deficit resulting in a hold on service for new denture clients.

5.2 Financial Commitments, Pressures and Risks Budget 2025

Briefing Note. C. Gardner, K. Ellis-Scharfenberg and J. Van Donkelaar presenting.

K. Ellis-Scharfenberg reviewed the contents of 5.2 Financial Commitments, Pressures and Risks Budget 2025 as follows:

- SMDHU will receive a 1% increase in the 2025 provincial grant; although that is predictable funding it does not equate to salary and operating cost increases.
- The Ministry of Health changed "one-time mitigation funding" by inserting it into the base component of the Ministry grant in 2024.
- Salary costs will continue to increase in 2025 noting the Board approved a 2% salary increase for ONA and non-union staff in 2025.
- Existing benefit costs (includes OMERS) continue to increase.
 Benefits were enhanced as part of the negotiated collective agreement in 2023 and apply to all employees and management.
 OMERS benefits are now available to employees that are casual, temporary and part-time impacting expenses to the agency.
- Ministry of Health is expected to continue to offset the costs for COVID-19 immunization programs. They are not expected to

reimburse for any expenses specific to COVID-19 outbreak and case management despite this work is a requirement as per memos from Chief Medical Officer and Health and draft Ontario Public Health Standards.

 Senior management has considered the new OPHS draft in the development of the 2025 budget.
