6. Business Arising

6.1 SMDHU and Artificial Intelligence

Briefing Note. S. Rebellato presenting.

Dr. S. Rebellato reviewed the contents of 6.1 SMDHU and Artificial Intelligence (AI) as follows:

There are two Al projects planned to launch in December 2024:

- 1. Generative AI chatbot designed to handle inquiries from the SMDHU website that provides reliable answers from SMDHU's health information.
 - A collaboration with the Wellington-Dufferin-Guelph (WDGPH) and Southwestern Public Health Units
 - All chatbot is currently undergoing rigorous testing for accuracy with evaluation supported by University of Waterloo
 - A soft launch on the SMDHU website is planned for mid-December
- 2. Al Scribe Pilot for Case Management:
 - A grant of \$74,000 from Public Health Ontario's Locally Driven Collaborative Projects (LDCP) will support the pilot and is to be shared between SMDHU and WDGPH

- Funding is required to be spent by March 2025
- The intent is to use the AI scribe to help reduce the administrative burden on case management staff
- Privacy and destruction measures are in place to meet Personal Health Information Protection Act (PHIPA) legislation

7.1 Simcoe Muskoka On the Move Active School Travel

Briefing Note. C. Bushey and M. Bovett presenting.

- C. Bushey and M. Bovett reviewed the contents of 7.1 Simcoe Muskoka On the Move Active School Travel as follows:
 - The Active School Travel pilot project began in 2019 funded by Ontario Active School Travel (OAST) to bring health unit, Municipal and School Board partners together with a focus to increase student physical activity by encouraging active school travel.
 - A variety of tools and resources have been developed using the OAST funding and are available on the Simcoe Muskoka On the Move website.
 - M. Bovett, Public Health Nurse in the Chronic Disease Prevention program is the Chair of the Simcoe Muskoka on the Move Steering committee that represents 7 municipalities (Appendix A lists member organizations).
 - The Simcoe Muskoka on the Move Steering committee is currently prioritizing expansion and sustainability of the On the Move

- initiative and has developed policy statements to share with municipalities and school boards.
- A letter has been developed for the SMDHU Board of Health Chair signature identifying concerns in response to the proposed Bill 212, Reducing Gridlock, Saving You Time Act, 2024 – framework for bicycle lanes that require removal of a traffic lane.
- A promotional video of the Alcona Glen Elementary School On the Move project was shared with the Board.
- The program is currently at capacity with 11 schools participating, and there is a wait list of interested schools. There will be a reevaluation of resources in the spring.
- The Board of Health encourages staff to bring this presentation to Municipal and District Councils, Community Wellness Committees and for consideration of Community Safety Well Being Plans.
- The Board held discussion on grant opportunities for funding assistance noting the City of Barrie Sports and Recreation grant and Huronia Community Foundation.
