6.1 2025 Draft Cost-Shared Budget and Dental Services Schedules Briefing Note. C. Gardner, K. Ellis-Scharfenberg and J. Van Donkelaar presenting.

K. Ellis-Scharfenberg shared a presentation and reviewed the contents of 6.1 2025 Draft Cost-Shared Budget and Dental Services Schedules as follows:

- A draft 2025 budget has been prepared based on the direction received at the October 16, 2024 Board of Health meeting of a 5.0% municipal levy increase and the Ministry of Health indication of a provincial grant increase of 1%.
- The Board discussed the 2025 Cost-Shared budget (Appendix A) including the potential for agency self-insurance and options to reduce postage and paper-based communication to clients. The potential for a presentation to Board in the future on communication approaches related to child vaccination requirements will be reviewed by staff.
- The 2025 budget requests a 1% increase on actual 2024 funding received for the Ontario Seniors Dental Care Program (Appendix B) that is funded 100% by the Ministry of Health.
- A separate process will commence early 2025 for Healthy Babies Healthy Children budget that is funded 100% by the Ministry of Children Community and Social Services.
